Women, Business and the Law 2024 (WBL 2024) identifies barriers for women's economic empowerment in three areas: women's legal rights, policy instruments designed to support the implementation of these rights, and how these rights are realized in practice. For that purpose, three new Women, Business and the Law 2.0 indexes are presented for ten indicators: (1) legal frameworks, (2) supportive frameworks, and (3) expert opinions. For the WBL 2.0 legal frameworks index, 40 questions are scored across the ten indicators for 190 economies. For the WBL 2.0 supportive frameworks index, 30 questions are scored across the ten indicators for 190 economies. Overall economy level legal and supportive frameworks scores are then calculated by taking the average of each indicator, with 100 representing the highest possible score. The WBL 2.0 expert opinions index is created for a total of 164 economies. Expert opinion scores are not available for Kyrgyz Republic due to an insufficient number of responses received from this economy during data collection.

For Kyrgyz Republic, data refer to the legal frameworks and supportive frameworks that are applicable to the main business city (Bishkek). The scores for Kyrgyz Republic are shown in the table below.

In summary, the **WBL 2.0 legal frameworks score** for Kyrgyz Republic (65.0 out of 100.0) is higher than the global average (64.2) and lower than the Europe & Central Asia regional average (77.0). When it comes to constraints on freedom of movement, constraints related to marriage and laws affecting women's property and inheritance, Kyrgyz Republic obtains a perfect score (100.0 out of 100.0). As an example, one of the lowest scores for Kyrgyz Republic is on the indicator measuring laws affecting women's safety. To improve on the Safety indicator, Kyrgyz Republic may wish to consider putting in place legislation on domestic violence, introducing legislation on femicide and adopting comprehensive legislation on sexual harassment.

The **WBL 2.0** supportive frameworks score for Kyrgyz Republic (51.7 out of 100.0) is higher than the global average (39.5) and higher than the Europe & Central Asia regional average (51.3). When it comes to supportive frameworks related to women starting and running a business, Kyrgyz Republic obtains a perfect score (100.0 out of 100.0). As an example, one of the lowest scores for Kyrgyz Republic is on the indicator measuring supportive frameworks affecting women's safety. To improve on the Safety indicator, Kyrgyz Republic may wish to consider developing comprehensive mechanisms to address violence against women, putting in place special procedures for cases of sexual harassment, designating a government entity responsible for the monitoring and implementation of national services, plans and programmes



addressing violence against women, providing an annual budgetary allocation towards violence against women risk mitigation and prevention and response programs.
