Women, Business and the Law 2024 (WBL 2024) identifies barriers for women's economic empowerment in three areas: women's legal rights, policy instruments designed to support the implementation of these rights, and how these rights are realized in practice. For that purpose, three new *Women, Business and the Law* 2.0 indexes are presented for ten indicators: (1) legal frameworks, (2) supportive frameworks, and (3) expert opinions. For the WBL 2.0 legal frameworks index, 40 questions are scored across the ten indicators for 190 economies. For the WBL 2.0 supportive frameworks index, 30 questions are scored across the ten indicators for 190 economies. Overall economy level legal and supportive frameworks scores are then calculated by taking the average of each indicator, with 100 representing the highest possible score. The WBL 2.0 expert opinions index is created for a total of 164 economies. Expert opinion scores are not available for 26 economies due to an insufficient number of responses received from those economies during data collection. Individual responses at the economy level for 15 expert opinions questions across the ten indicators are scored by taking the median value of all responses per question. The economy level expert opinions index is equal to the simple unweighted average of the ten indicator scores.

For Federated States of Micronesia, data refer to the legal frameworks, supportive frameworks, and expert opinions that are applicable to the main business city (Island of Pohnpei (Palikir/Kolonia)). The scores for Federated States of Micronesia are shown in the table below.

In summary, the **WBL 2.0 legal frameworks score** for Federated States of Micronesia (45.0 out of 100.0) is lower than the global average (64.2) and lower than the East Asia & Pacific regional average (57.8). When it comes to constraints on freedom of movement and constraints related to marriage, Federated States of Micronesia obtains a perfect score (100.0 out of 100.0). As an example, one of the lowest scores for Federated States of Micronesia is on the indicator measuring laws affecting women's safety. To improve on the Safety indicator, Federated States of Micronesia may wish to consider putting in place legislation on domestic violence, introducing legislation on femicide, adopting comprehensive legislation on sexual harassment and introducing legislation on child marriage.





The **WBL 2.0 supportive frameworks score** for Federated States of Micronesia (11.7 out of 100.0) is lower than the global average (39.5) and lower than the East Asia & Pacific regional average (33.9). Federated States of Micronesia does not attain a perfect score on any of the WBL 2.0 supportive frameworks indicators. There is room for improvement across all ten indicators. As an example, one of the lowest scores for Federated States of Micronesia is on the indicator measuring supportive frameworks affecting women's safety. To improve on the Safety indicator, Federated States of Micronesia may wish to consider developing comprehensive mechanisms to address violence against women, putting in place special procedures for cases of sexual harassment, designating a government entity responsible for the monitoring and implementation of national services, plans and programmes addressing violence against women, providing an annual budgetary allocation towards violence against women risk mitigation and prevention and response programs.

The **WBL 2.0 expert opinions score** for Federated States of Micronesia (52.5 out of 100.0) is lower than the global average (65.7) and lower than the East Asia & Pacific regional average (64.8). When it comes to expert opinions on freedom of movement, Federated States of Micronesia obtains a perfect score (100.0 out of 100.0). As an example, one of the lowest scores for Federated States of Micronesia is on the indicator measuring expert opinions on women's pay.
