Azerbaijan

Women, Business and the Law 2024 (WBL2024) presents an index covering 190 economies and structured around the life cycle of a working woman. In total, 35 questions are scored across eight indicators. Overall scores are then calculated by taking the average of each indicator, with 100 representing the highest possible score. Data refer to the laws and regulations that are applicable to the main business city (Baku). Different rules may apply in other jurisdictions so local legislation should be reviewed. Based on this approach, **Azerbaijan scores 85.0 out of 100.0.** The overall score for Azerbaijan is lower than the regional average observed across Europe and Central Asia (85.8). Within the Europe and Central Asia region, the maximum score observed is 96.9 (Cyprus).

Relative Strengths

When it comes to constraints on freedom of movement, laws affecting women's decisions to work, constraints related to marriage, constraints on women starting and running a business, and gender differences in property and inheritance, Azerbaijan gets a perfect score.

Areas for Improvement

When it comes to laws affecting women's pay, laws affecting women's work after having children, and laws affecting the size of a woman's pension, Azerbaijan could consider reforms to improve legal equality for women.

For example, one of the lowest scores for Azerbaijan is on the indicator measuring laws affecting women's pay (the WBL2024 Pay indicator). To improve on the Pay indicator, Azerbaijan may wish to consider mandating equal remuneration for work of equal value, and allowing women to work at night in the same way as men.

Recent Reforms

During the past year (October 2nd, 2022 to October 1st, 2023), Azerbaijan removed restrictions on a woman's employment in industrial jobs and jobs deemed dangerous.
