Burkina Faso

Women, Business and the Law 2024 (WBL2024) presents an index covering 190 economies and structured around the life cycle of a working woman. In total, 35 questions are scored across eight indicators. Overall scores are then calculated by taking the average of each indicator, with 100 representing the highest possible score. Data refer to the laws and regulations that are applicable to the main business city (Ouagadougou). Different rules may apply in other jurisdictions so local legislation should be reviewed. Based on this approach, **Burkina Faso scores 82.5 out of 100.0.** The overall score for Burkina Faso is higher than the regional average observed across Sub-Saharan Africa (74.0). Within the Sub-Saharan Africa region, the maximum score observed is 97.5 (Togo).

Relative Strengths

When it comes to laws affecting women's decisions to work, constraints on women starting and running a business, gender differences in property and inheritance, and laws affecting the size of a woman's pension, Burkina Faso gets a perfect score.

Areas for Improvement

When it comes to constraints on freedom of movement, laws affecting women's pay, constraints related to marriage, and laws affecting women's work after having children, Burkina Faso could consider reforms to improve legal equality for women.

For example, one of the lowest scores for Burkina Faso is on the indicator measuring laws affecting women's pay (the WBL2024 Pay indicator). To improve on the Pay indicator, Burkina Faso may wish to consider mandating equal remuneration for work of equal value, allowing women to work in jobs deemed dangerous in the same way as men, and allowing women to work in an industrial job in the same way as men.

Recent Reforms

No reforms were observed during the past year (October 2nd, 2022 - October 1st, 2023).
