Cyprus

Women, Business and the Law 2024 (WBL2024) presents an index covering 190 economies and structured around the life cycle of a working woman. In total, 35 questions are scored across eight indicators. Overall scores are then calculated by taking the average of each indicator, with 100 representing the highest possible score. Data refer to the laws and regulations that are applicable to the main business city (Nicosia). Different rules may apply in other jurisdictions so local legislation should be reviewed. Based on this approach, **Cyprus scores 96.9 out of 100.0.** The overall score for Cyprus is higher than the regional average observed across Europe and Central Asia (85.8). Within the Europe and Central Asia region, Cyprus obtains the highest score.

Relative Strengths

When it comes to constraints on freedom of movement, laws affecting women's decisions to work, constraints related to marriage, laws affecting women's work after having children, constraints on women starting and running a business, gender differences in property and inheritance, and laws affecting the size of a woman's pension, Cyprus gets a perfect score.

Areas for Improvement

When it comes to laws affecting women's pay, Cyprus could consider reforms to improve legal equality for women.

For example, the lowest score for Cyprus is on the indicator measuring laws affecting women's pay (the WBL2024 Pay indicator). To improve on the Pay indicator, Cyprus may wish to consider allowing women to work in an industrial job in the same way as men.

Recent Reforms

During the past year (October 2nd, 2022 to October 1st, 2023), Cyprus introduced six weeks of parental leave as an individual and nontransferable right to each parent.
