Djibouti

Women, Business and the Law 2024 (WBL2024) presents an index covering 190 economies and structured around the life cycle of a working woman. In total, 35 questions are scored across eight indicators. Overall scores are then calculated by taking the average of each indicator, with 100 representing the highest possible score. Data refer to the laws and regulations that are applicable to the main business city (Djibouti Ville). Different rules may apply in other jurisdictions so local legislation should be reviewed. Based on this approach, **Djibouti scores 71.3 out of 100.0.** The overall score for Djibouti is higher than the regional average observed across the Middle East and North Africa (54.7). Within the Middle East and North Africa region, the maximum score observed is 91.3 (Malta).

Relative Strengths

When it comes to constraints on freedom of movement, laws affecting women's decisions to work, constraints on women starting and running a business, and laws affecting the size of a woman's pension, Djibouti gets a perfect score.

Areas for Improvement

When it comes to laws affecting women's pay, constraints related to marriage, laws affecting women's work after having children, and gender differences in property and inheritance, Djibouti could consider reforms to improve legal equality for women.

For example, one of the lowest scores for Djibouti is on the indicator measuring constraints related to marriage (the WBL2024 Marriage indicator). To improve on the Marriage indicator, Djibouti may wish to consider no longer requiring a married woman to obey her husband, allowing women to be head of household in the same way as men, allowing women to obtain a divorce in the same way as men, and giving women the same rights to remarry as men.

Recent Reforms

No reforms were observed during the past year (October 2nd, 2022 - October 1st, 2023).
