# Malaysia

Women, Business and the Law 2024 (WBL2024) presents an index covering 190 economies and structured around the life cycle of a working woman. In total, 35 questions are scored across eight indicators. Overall scores are then calculated by taking the average of each indicator, with 100 representing the highest possible score. Data refer to the laws and regulations that are applicable to the main business city (Kuala Lumpur). Different rules may apply in other jurisdictions so local legislation should be reviewed. Based on this approach, **Malaysia scores 60.6 out of 100.0.** The overall score for Malaysia is lower than the regional average observed across East Asia and the Pacific (73.0). Within the East Asia and the Pacific region, the maximum score observed is 91.9 (Hong Kong SAR, China).

# **Relative Strengths**

Malaysia does not attain a perfect score on any of the WBL2024 indicators. There is room for improvement across all eight indicators.

## **Areas for Improvement**

When it comes to constraints on freedom of movement, laws affecting women's decisions to work, laws affecting women's pay, constraints related to marriage, laws affecting women's work after having children, constraints on women starting and running a business, gender differences in property and inheritance, and laws affecting the size of a woman's pension, Malaysia could consider reforms to improve legal equality for women.

For example, one of the lowest scores for Malaysia is on the indicator measuring constraints related to marriage (the WBL2024 Marriage indicator). To improve on the Marriage indicator, Malaysia may wish to consider no longer requiring a married woman to obey her husband, allowing women to obtain a divorce in the same way as men, and giving women the same rights to remarry as men.

#### **Recent Reforms**

During the past year (October 2nd, 2022 to October 1st, 2023), Malaysia removed restrictions on a woman's employment in industrial jobs. Malaysia increased paid maternity leave from 60 days to 98 days, introduced seven days of paid paternity leave, and prohibited the dismissal of pregnant workers.
