## Niger

Women, Business and the Law 2024 (WBL2024) presents an index covering 190 economies and structured around the life cycle of a working woman. In total, 35 questions are scored across eight indicators. Overall scores are then calculated by taking the average of each indicator, with 100 representing the highest possible score. Data refer to the laws and regulations that are applicable to the main business city (Niamey). Different rules may apply in other jurisdictions so local legislation should be reviewed. Based on this approach, **Niger scores 53.8 out of 100.0.** The overall score for Niger is lower than the regional average observed across Sub-Saharan Africa (74.0). Within the Sub-Saharan Africa region, the maximum score observed is 97.5 (Togo).

## **Relative Strengths**

When it comes to laws affecting the size of a woman's pension, Niger gets a perfect score.

## **Areas for Improvement**

When it comes to constraints on freedom of movement, laws affecting women's decisions to work, laws affecting women's pay, constraints related to marriage, laws affecting women's work after having children, constraints on women starting and running a business, and gender differences in property and inheritance, Niger could consider reforms to improve legal equality for women.

For example, one of the lowest scores for Niger is on the indicator measuring gender differences in property and inheritance (the WBL2024 Assets indicator). To improve on the Assets indicator, Niger may wish to consider granting spouses equal rights to immovable property, equalizing inheritance rights for sons and daughters, equalizing inheritance rights for male and female surviving spouses, granting spouses equal administrative authority over assets during marriage, and recognizing the value of nonmonetary contributions.

## **Recent Reforms**

No reforms were observed during the past year (October 2nd, 2022 - October 1st, 2023).
