United Arab Emirates

Women, Business and the Law 2024 (WBL2024) presents an index covering 190 economies and structured around the life cycle of a working woman. In total, 35 questions are scored across eight indicators. Overall scores are then calculated by taking the average of each indicator, with 100 representing the highest possible score. Data refer to the laws and regulations that are applicable to the main business city (Dubai). Different rules may apply in other jurisdictions so local legislation should be reviewed. Based on this approach, **United Arab Emirates scores 82.5 out of 100.0.** The overall score for United Arab Emirates is higher than the regional average observed across the Middle East and North Africa (54.7). Within the Middle East and North Africa region, the maximum score observed is 91.3 (Malta).

Relative Strengths

When it comes to constraints on freedom of movement, laws affecting women's decisions to work, laws affecting women's pay, constraints on women starting and running a business, and laws affecting the size of a woman's pension, United Arab Emirates gets a perfect score.

Areas for Improvement

When it comes to constraints related to marriage, laws affecting women's work after having children, and gender differences in property and inheritance, United Arab Emirates could consider reforms to improve legal equality for women.

For example, one of the lowest scores for United Arab Emirates is on the indicator measuring gender differences in property and inheritance (the WBL2024 Assets indicator). To improve on the Assets indicator, United Arab Emirates may wish to consider equalizing inheritance rights for sons and daughters, equalizing inheritance rights for male and female surviving spouses, and recognizing the value of nonmonetary contributions.

Recent Reforms

No reforms were observed during the past year (October 2nd, 2022 - October 1st, 2023).
