Uzbekistan

Women, Business and the Law 2024 (WBL2024) presents an index covering 190 economies and structured around the life cycle of a working woman. In total, 35 questions are scored across eight indicators. Overall scores are then calculated by taking the average of each indicator, with 100 representing the highest possible score. Data refer to the laws and regulations that are applicable to the main business city (Tashkent). Different rules may apply in other jurisdictions so local legislation should be reviewed. Based on this approach, **Uzbekistan scores 82.5 out of 100.0.** The overall score for Uzbekistan is lower than the regional average observed across Europe and Central Asia (85.8). Within the Europe and Central Asia region, the maximum score observed is 96.9 (Cyprus).

Relative Strengths

When it comes to constraints on freedom of movement, laws affecting women's pay, constraints related to marriage, constraints on women starting and running a business, and gender differences in property and inheritance, Uzbekistan gets a perfect score.

Areas for Improvement

When it comes to laws affecting women's decisions to work, laws affecting women's work after having children, and laws affecting the size of a woman's pension, Uzbekistan could consider reforms to improve legal equality for women.

For example, one of the lowest scores for Uzbekistan is on the indicator measuring laws affecting women's decisions to work (the WBL2024 Workplace indicator). To improve on the Workplace indicator, Uzbekistan may wish to consider enacting legislation protecting women from sexual harassment in employment, and adopting criminal or civil penalties for sexual harassment in employment.

Recent Reforms

During the past year (October 2nd, 2022 to October 1st, 2023), Uzbekistan mandated equal remuneration for work of equal value and removed restrictions on a woman's employment in industrial jobs and jobs deemed dangerous. Uzbekistan enacted legislation protecting a woman from domestic violence.
