Bolivia

Women, Business and the Law 2020 presents an index covering 190 economies and structured around the life cycle of a working woman. In total, 35 questions are scored across the eight indicators. Overall scores are then calculated by taking the average of each indicator, with 100 representing the highest possible score. Data refer to the laws and regulations that are applicable to the main business city (La Paz). Different rules may apply in other jurisdictions so local legislation should be reviewed. Based on this approach, **Bolivia scores 82.5 out of 100.** The overall score for Bolivia is higher than the regional average observed across Latin America & Caribbean (79.2).

Relative Strengths

When it comes to constraints on freedom of movement, constraints related to marriage, constraints on women's starting and running a business, and gender differences in property and inheritance, Bolivia gets a perfect score.

Areas for Improvement

However, when it comes to laws affecting women's decisions to work, laws affecting women's pay, laws affecting women's work after having children, and laws affecting the size of a women's pension, Bolivia could consider reforms to improve legal equality for women.

For example, one of the lowest scores for Bolivia is on the indicator related to laws affecting women's pay (the WBL2020 Pay Indicator). To improve on the Pay Indicator, Bolivia may wish to consider allowing women to work the same night hours as men, and allowing women to work in jobs deemed dangerous in the same way as men.

Recent Reforms (2018-2019)

No reforms impacting the WBL2020 indicators have been observed during the past two years.
