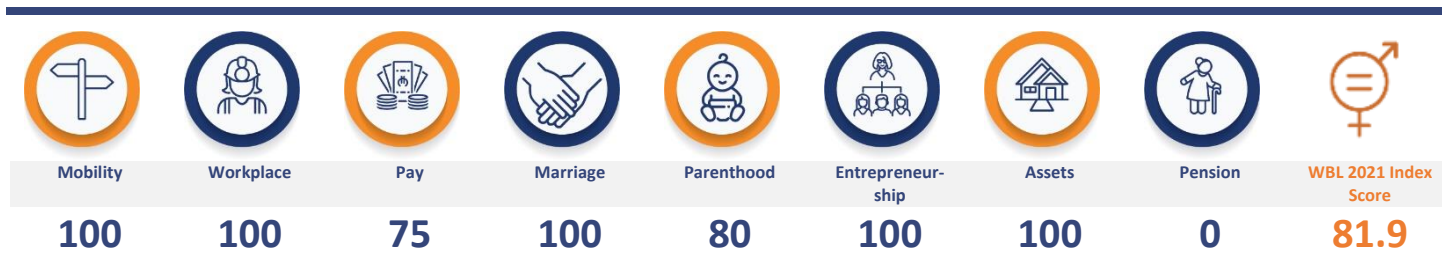


Vietnam

Women, Business and the Law 2021 presents an index covering 190 economies and structured around the life cycle of a working woman. In total, 35 questions are scored across the eight indicators. Overall scores are then calculated by taking the average of each indicator, with 100 representing the highest possible score. Data refer to the laws and regulations that are applicable to the main business city (Ho Chi Minh City). Different rules may apply in other jurisdictions so local legislation should be reviewed. Based on this approach, **Vietnam scores 81.9 out of 100**. The overall score for Vietnam is higher than the regional average observed across East Asia & Pacific (71.9). Within the East Asia & Pacific region, the maximum score observed is 91.3 (Taiwan, China).

Relative Strengths

When it comes to constraints on freedom of movement, laws affecting women's decisions to work, constraints related to marriage, constraints on women's starting and running a business, and gender differences in property and inheritance, Vietnam gets a perfect score.

Areas for Improvement

However, when it comes to laws affecting women's pay, laws affecting women's work after having children, and laws affecting the size of a woman's pension, Vietnam could consider reforms to improve legal equality for women.

For example, one of the lowest scores for Vietnam is on the indicator related to laws affecting the size of a woman's pension (the WBL2021 Pension Indicator). To improve on the Pension Indicator, Vietnam may wish to consider equalizing the ages at which men and women can retire with full pension benefits, equalizing the ages at which men and women can retire with partial pension benefits, equalizing the mandatory retirement age for men and women, and accounting for periods of absence from work due to childcare in pension benefits.

Recent Reforms

Vietnam eliminated restrictions on women's employment in jobs deemed dangerous.
