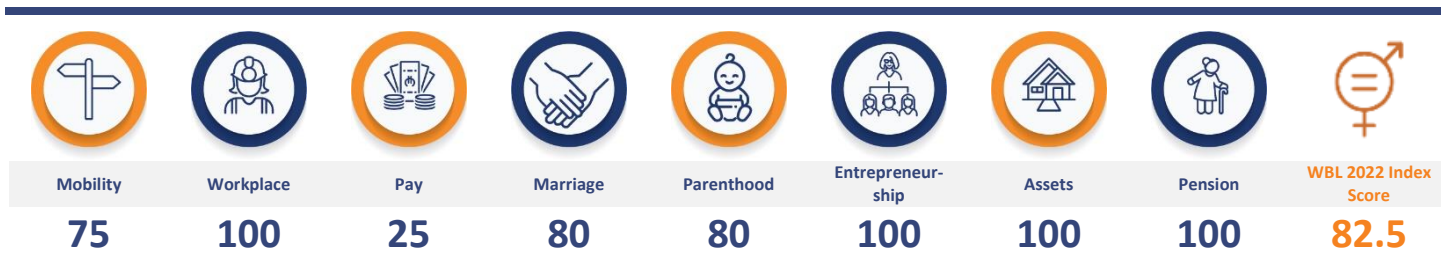


# Gabon

*Women, Business and the Law 2022* (WBL2022) presents an index covering 190 economies and structured around the life cycle of a working woman. In total, 35 questions are scored across eight indicators. Overall scores are then calculated by taking the average of each indicator, with 100 representing the highest possible score. Data refer to the laws and regulations that are applicable to the main business city (Libreville). Different rules may apply in other jurisdictions so local legislation should be reviewed. Based on this approach, **Gabon scores 82.5 out of 100**. The overall score for Gabon is higher than the regional average observed across Sub-Saharan Africa (71.5). Within the Sub-Saharan Africa region, the maximum score observed is 89.4 (Mauritius).

## Relative Strengths

When it comes to laws affecting women's decisions to work, constraints on women starting and running a business, gender differences in property and inheritance, and laws affecting the size of a woman's pension, Gabon gets a perfect score.

## Areas for Improvement

However, when it comes to constraints on freedom of movement, laws affecting women's pay, constraints related to marriage, and laws affecting women's work after having children, Gabon could consider reforms to improve legal equality for women.

For example, one of the lowest scores for Gabon is on the indicator measuring laws affecting women's pay (the WBL2022 Pay indicator). To improve on the Pay indicator, Gabon may wish to consider mandating equal remuneration for work of equal value, allowing women to work in jobs deemed dangerous in the same way as men, and allowing women to work in an industrial job in the same way as men.

## Recent Reforms

During the past year (October 2nd, 2020 – October 1st, 2021), Gabon granted spouses equal rights to immovable property and equal administrative authority over assets during marriage. Gabon allowed women to open a bank account in the same way as men and made access to credit easier for women by prohibiting gender-based discrimination in financial services. Gabon no longer requires a married woman to obey her husband and allows women to be head of household in the same way as men. Gabon also enacted legislation protecting women from domestic violence. Gabon allowed women to choose where to live in the same way as men. Gabon allowed a woman to get a job without permission from her husband.
