Bosnia and Herzegovina

Women, Business and the Law 2023 (WBL2023) presents an index covering 190 economies and structured around the life cycle of a working woman. In total, 35 questions are scored across eight indicators. Overall scores are then calculated by taking the average of each indicator, with 100 representing the highest possible score. Data refer to the laws and regulations that are applicable to the main business city (Sarajevo). Different rules may apply in other jurisdictions so local legislation should be reviewed. Based on this approach, **Bosnia and Herzegovina scores 85 out of 100.** The overall score for Bosnia and Herzegovina is higher than the regional average observed across Europe and Central Asia (84.4). Within the Europe and Central Asia region, the maximum score observed is 94.4 (Cyprus).

Relative Strengths

When it comes to constraints on freedom of movement, laws affecting women's decisions to work, constraints related to marriage, constraints on women starting and running a business, and gender differences in property and inheritance, Bosnia and Herzegovina gets a perfect score.

Areas for Improvement

However, when it comes to laws affecting women's pay, laws affecting women's work after having children, and laws affecting the size of a woman's pension, Bosnia and Herzegovina could consider reforms to improve legal equality for women.

For example, one of the lowest scores for Bosnia and Herzegovina is on the indicator measuring laws affecting women's pay (the WBL2023 Pay indicator). To improve on the Pay indicator, Bosnia and Herzegovina may wish to consider allowing women to work at night in the same way as men, and allowing women to work in an industrial job in the same way as men.

Recent Reforms

No reforms were observed during the past year (October 2nd, 2021 - October 1st, 2022).
