Gabon

Women, Business and the Law 2023 (WBL2023) presents an index covering 190 economies and structured around the life cycle of a working woman. In total, 35 questions are scored across eight indicators. Overall scores are then calculated by taking the average of each indicator, with 100 representing the highest possible score. Data refer to the laws and regulations that are applicable to the main business city (Libreville). Different rules may apply in other jurisdictions so local legislation should be reviewed. Based on this approach, **Gabon scores 95 out of 100.** The overall score for Gabon is higher than the regional average observed across Sub-Saharan Africa (72.6). Within the Sub-Saharan Africa region, the maximum score observed is 95 (Côte d'Ivoire and Gabon).

Relative Strengths

When it comes to constraints on freedom of movement, laws affecting women's decisions to work, laws affecting women's pay, constraints on women starting and running a business, gender differences in property and inheritance, and laws affecting the size of a woman's pension, Gabon gets a perfect score.

Areas for Improvement

However, when it comes to constraints related to marriage, and laws affecting women's work after having children, Gabon could consider reforms to improve legal equality for women.

For example, one of the lowest scores for Gabon is on the indicator measuring constraints related to marriage (the WBL2023 Marriage indicator). To improve on the Marriage indicator, Gabon may wish to consider giving women the same rights to remarry as men.

Recent Reforms

During the past year (October 2nd, 2021 to October 1st, 2022), Gabon enacted legislation allowing women to apply for a passport in the same way as men. Gabon mandated equal remuneration for work of equal value. It also eliminated all restrictions on women's employment. Women can now work in industrial jobs and in jobs deemed dangerous in the same way as men.
