# Myanmar

Women, Business and the Law 2023 (WBL2023) presents an index covering 190 economies and structured around the life cycle of a working woman. In total, 35 questions are scored across eight indicators. Overall scores are then calculated by taking the average of each indicator, with 100 representing the highest possible score. Data refer to the laws and regulations that are applicable to the main business city (Yangon). Different rules may apply in other jurisdictions so local legislation should be reviewed. Based on this approach, **Myanmar scores 58.8 out of 100.** The overall score for Myanmar is lower than the regional average observed across East Asia and the Pacific (72.6). Within the East Asia and the Pacific region, the maximum score observed is 91.9 (Hong Kong SAR, China).

### **Relative Strengths**

Myanmar does not attain a perfect score on any of the WBL2023 indicators. There is room for improvement across all eight indicators.

## **Areas for Improvement**

However, when it comes to constraints on freedom of movement, laws affecting women's decisions to work, laws affecting women's pay, constraints related to marriage, laws affecting women's work after having children, constraints on women starting and running a business, gender differences in property and inheritance, and laws affecting the size of a woman's pension, Myanmar could consider reforms to improve legal equality for women.

For example, one of the lowest scores for Myanmar is on the indicator measuring laws affecting women's decisions to work (the WBL2023 Workplace indicator). To improve on the Workplace indicator, Myanmar may wish to consider prohibiting discrimination in employment based on gender, enacting legislation protecting women from sexual harassment in employment, and adopting criminal or civil penalties for sexual harassment in employment.

#### **Recent Reforms**

No reforms were observed during the past year (October 2nd, 2021 – October 1st, 2022).
