San Marino

Women, Business and the Law 2023 (WBL2023) presents an index covering 190 economies and structured around the life cycle of a working woman. In total, 35 questions are scored across eight indicators. Overall scores are then calculated by taking the average of each indicator, with 100 representing the highest possible score. Data refer to the laws and regulations that are applicable to the main business city (San Marino). Different rules may apply in other jurisdictions so local legislation should be reviewed. Based on this approach, **San Marino scores 80 out of 100.** The overall score for San Marino is lower than the regional average observed across Europe and Central Asia (84.4). Within the Europe and Central Asia region, the maximum score observed is 94.4 (Cyprus).

Relative Strengths

When it comes to constraints on freedom of movement, gender differences in property and inheritance, and laws affecting the size of a woman's pension, San Marino gets a perfect score.

Areas for Improvement

However, when it comes to laws affecting women's decisions to work, laws affecting women's pay, constraints related to marriage, laws affecting women's work after having children, and constraints on women starting and running a business, San Marino could consider reforms to improve legal equality for women.

For example, one of the lowest scores for San Marino is on the indicator measuring laws affecting women's decisions to work (the WBL2023 Workplace indicator). To improve on the Workplace indicator, San Marino may wish to consider enacting legislation protecting women from sexual harassment in employment, and adopting criminal or civil penalties for sexual harassment in employment.

Recent Reforms

No reforms were observed during the past year (October 2nd, 2021 - October 1st, 2022).
