# Sierra Leone

Women, Business and the Law 2023 (WBL2023) presents an index covering 190 economies and structured around the life cycle of a working woman. In total, 35 questions are scored across eight indicators. Overall scores are then calculated by taking the average of each indicator, with 100 representing the highest possible score. Data refer to the laws and regulations that are applicable to the main business city (Freetown). Different rules may apply in other jurisdictions so local legislation should be reviewed. Based on this approach, **Sierra Leone scores 72.5 out of 100.** The overall score for Sierra Leone is lower than the regional average observed across Sub-Saharan Africa (72.6). Within the Sub-Saharan Africa region, the maximum score observed is 95 (Côte d'Ivoire and Gabon).

### **Relative Strengths**

When it comes to constraints on freedom of movement, constraints related to marriage, and constraints on women starting and running a business, Sierra Leone gets a perfect score.

## **Areas for Improvement**

However, when it comes to laws affecting women's decisions to work, laws affecting women's pay, laws affecting women's work after having children, gender differences in property and inheritance, and laws affecting the size of a woman's pension, Sierra Leone could consider reforms to improve legal equality for women.

For example, one of the lowest scores for Sierra Leone is on the indicator measuring laws affecting women's work after having children (the WBL2023 Parenthood indicator). To improve on the Parenthood indicator, Sierra Leone may wish to consider making paid leave of at least 14 weeks available to mothers, making the government administer 100% of maternity leave benefits, making paid leave available to fathers, making paid parental leave available, and prohibiting the dismissal of pregnant workers.

#### **Recent Reforms**

No reforms were observed during the past year (October 2nd, 2021 - October 1st, 2022).
