Guinea-Bissau is one of 12 economies in the Sub-Saharan Africa region with laws that allow employees to request flexible work.

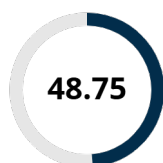


Reforms

From October 2, 2023, to October 1, 2025, Guinea-Bissau did not enact any reforms affecting the topics measured by WBL.

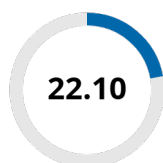

- **LEGAL FRAMEWORKS:** Guinea-Bissau scores lower than both the global average (66.97) and the Sub-Saharan Africa regional average (59.55). However, at the topic level, it has higher scores than the regional average in Safety, Work, Assets and Pension.
- **SUPPORTIVE FRAMEWORKS:** Guinea-Bissau falls below both the global average (46.83) and the Sub-Saharan Africa regional average (32.99). However, at the topic level, it scores above the regional average in Mobility and Marriage.
- **ENFORCEMENT PERCEPTIONS:** Guinea-Bissau's score is below both the global average (53.31) and the Sub-Saharan Africa regional average (45.02).
